Your membership in PWEA-Retired, VEA-Retired, and NEA-Retired helps your Associations achieve our goals for schools, for active school employees, and for retirees. When you join VEA-Retired/NEA-Retired as a lifetime member, you are automatically enrolled as a lifetime member of PWEA-Retired and are eligible for all benefits of membership.

Who's Eligible

VEA-Retired and NEA-Retired are programs of the Virginia Education Association and National Education Association for those who have retired from employment in the field of public education. Lifetime membership in VEA-Retired is available to retired educators and active VEA members prior to their retirement. Membership is open to all who worked in Virginia public schools, even if they now live out of state. Membership in PWEA-Retired is available to retired NEA members and current VEA-R/NEA-R members living in or near Prince William County, Virginia, regardless of local NEA-affiliate membership prior to retirement.
